Rex Education in partnership with the Senate Committee on Finance, the Office of the Speaker of the House of Representatives (HOR), the Department of the Interior and Local Government (DILG), the Department of Education (DepEd), the ECCD Council and the Ateneo School of Government (ASoG), is instituting the GAWAD EDUKAMPYON FOR LOCAL GOVERNANCE with GAWAD EDUKAMPYON FOR ECCD as one of its categories.

The Gawad Edukampyon for ECCD recognition will be awarded to three (3) Provinces, three (3) Highly-Urbanized Cities and three (3) Component Cities and/or Municipalities for its exemplary and innovative program, projects and activities in the field of ECCD. This will be an institutional award (LGU) for being champions of early childhood care and development in compliance with the ECCD Council's program delivery and other standards, at the minimum, and implementing innovative and effective supplementary programs on early development and promotion of proper health and nutrition.

The specific criteria for screening/evaluating are as follows;

A. For being champions of Early Childhood Care and Development as manifested in//by:

- 1. Compliance with ECCD Council program delivery and other standards, at the minimum (e.g., number of children enrolled in CDCs vis-a-vis the 0 4 years old population; recognized/accredited CDC/LC, etc.)
- 2. Innovative and effective supplementary programs on early stimulation (development) and promotion of proper health and nutrition (e.g., alternative delivery of an integrated service but not limited to health and nutrition programs, Home-based Program, Mobile ECCD, Project Approach, CBPAV, PtoP, ERPATs, FSP, PES, etc.)

 - 2. Inter-agency/unit and multi-stakeholder appreciation of the importance of ECCD and involvement in ECCD program implementation (e.g., multisectoral and interagency partnership between and among national and international government and nongovernment organizations)
