 The Early Childhood Care and Development Council (ECCDC) is in need of a CONTRACTOR that will undertake the monthly preventive maintenance service for existing twenty (20) units Aircons: split type aircons (floor & wall mounted) & air curtain type located at 4/F Belvedere Tower, No. 15 San Miguel Avenue, Ortigas Center Pasig City, on a monthly basis from January to December 2025.

2. SCOPE OF SERVICES

- a. The **Contractor** shall perform the following monthly services.
 - i. inspect all components of the system, check operation and make all necessary adjustment: clean equipment, evaporator, condenser coils, wash air filters, drain lines and drain pans;
 - ii. lubricate all moving parts where and when possible;
 - iii. check all thermostat and electrical controls;
 - iv. test system for refrigerant leaks; and
 - v. inspect belts and adjust if necessary for correct tension and alignment.
- b. Parts/materials and labor cost on major services rendered has 90 days warranty;
- c. Labor and supervision in attending to field trouble calls anytime (minor repair only) undertaken during regular business hours;
- d. Prepare Work Request with complete information needed and other documents;
- e. Any abnormalities and/or beyond Air conditioning System operating specifications found shall be reported to the ECCDC for recommendation and/or immediate correction. Service Report shall be submitted every maintenance indicating all action done and findings.

3. EXCLUSIONS

- a. Labor and supervision for repainting, reconditioning and overhauling jobs;
- b. Cost of materials and/ or spare parts, used in either field or shop repair;
- c. Cost of expendable items like Freon, oil welding materials, etc.
- d. Labor and supervision for repairs undertaken in the field and shop. (Such as all types of refrigerant leaks, bearing replacement, stuck-up compressor, burn-out compressor).

4. PAYMENT CHARGES
